MINUTES OF MEETING OF AD-HOC COMMITTEE
HELD ON 07TH MAY 2016

Attendance

1. Meeting of the Ad-hoc Committee (constituted by District Registrar) was held on 7th May 2016 which was attended by all the 5 (five) members viz Brig Sarjit Singh, Convener; Brig SMS Ratour; Col SK Chauhan; Col VK Seth VSM; and Sh. Subhash C Pathania members.

Deliberations

2. Brig Sarjit Singh (Retd) Convener welcomed the members and apprised them that the District Registrar has devolved certain limited responsibilities on him as a Convener of the Ad-hoc Committee to run the day to day affairs of the Society. At this Sh. SC Pathania apprised the Convener that a letter signed by 14 (fourteen) members has been written on 05 May 2016 to the District Registrar with a copy to Ad-hoc Committee which was read out by him as advised by the Convener to the Members. Accordingly the unanimous decision by the Ad-hoc Committee was taken that further action on declaring of election against the vacancies occurred on account of resignations shall be taken after receipt of relevant directions/decision of the District Registrar on the aforesaid representation.

3. The Convener assigned the area of responsibility to each of the 5 (inclusive of himself) ad-hoc committee members and hoped that each one of them shall carry out the same to his utmost capability and dedication till the new incumbents are duly elected/placed.

4. Col VK Seth VSM suggested that normal day to day functioning/payment of workers salary etc should not suffer/delayed to which all members agreed.

5. Col SK Chauhan opined that there are 3 (three) electricians and one can be reduced as two of them are sufficient to handle the maint of elct eqpt/panels. The Convener Brig Sarjit Singh however, clarified that the 3rd electrician was employed on temp basis for a specific job of replacing/fixing LED lights and therefore left it to the wisdom of Elect in-charge Col SK Chauhan to take appropriate decision on this matter.

6. Brig SMS Rathour apprised the Members that granite tiles of walls in certain area of D-5 Block are precariously falling endangering the life of occupants. He has enquired from the Contractor in this regard and the total cost of repairs shall be between Rs. 5500 to Rs. 6,000/-. He therefore recommended that this may be got done on priority basis to which all members agreed.

7. There being no other point for discussion, meeting ended with a note of thanks to the Chair.
