

MINUTES OF THE SPL GEN BODY MEETING OF GHS-79 HELD ON 16 JUN 2013 are appended for the information of all members pl.

"Attendance:

1. The Spl GBM held on 16 Jun 2013 was attended by 55 members of the Society under the aegis of Lt Gen (Retd) AN Aul, PVSM, UYSM, AVSM and Brig KC Sood.

Agenda:

2. Formation of Adhoc Management Committee as per orders by State Registrar of Societies, Chandigarh against Appeal No 29/2013 filed by some of the members. Lt Gen (Retd) AN Aul and Brig KC Sood were requested to coordinate the election of Adhoc Committee. Total 25 nominations of volunteer members were received by the coordinators before commencement of meeting.

Address by Lt Gen (Retd) , PVSM, UYSM, AVSM:

3. At the outset General Aul advised all the members to value/up-hold the ethos & ethics of a true Soldier and sincerely partake for the betterment of the Society. He further advised that we should solve all issues through dialogue and free discussion amongst ourselves so that there should not be any unsavory chance for an outside Administrator to be imposed on us. Thereafter he read out the names of all the 25 Members who had volunteered themselves to work selflessly for the betterment of the Society and asked all the Members to propose/choose the names for the post of President. Col DB Singh proposed the name of Col BS Chowdhary as President. Col Arjun Singh's name was also proposed by a member – Col H O Khandelwal but Col Arjun Singh was not found present in the meeting then and therefore the proposal was dropped. Col H O Khandelwal thereafter proposed the name of Col Subhash Chander Joshi, to which the later did not agree himself. General Aul time and again announced that the members are at liberty to propose any other candidate(s) for the post of President. Since no other proposal came forward, General Aul declared Col BS Chowdhary as elected to be a President of the Adhoc Governing Body of Sandeep Vihar Residents Welfare Society (GHS-79) and Col Chowdhary agreed/accepted this assignment. General Aul thereafter advised Col BS Chowdhary to address the assembly as President and also select his team for the Ad-hoc Governing Body.
