## MINUTES OF SPECIAL MEETING OF MANAGING COMMITTEE HELD ON 26TH MAY 2017

#### **Attendance**

1. A special meeting of Managing Committee was held on 26<sup>th</sup> May 2017 which was attended by 10 (ten) out of 11 (Eleven) Committee Members to deliberate upon the following agenda points.

#### Agenda

- 2. a) Developments in Court Case filed in NCGRC, New Delhi;
  - b) Conduct of Elections of the Collegium/Managing Committee; and
  - b) Any other point(s) with the permission of the Chair.

#### **Discussions**

- 3 Sh Subhash C Pathania, General Secretary wished well to all the members of the Managing Committee assembled there for the special meeting at a short notice. He, with the permission of the Chair, read out the main agenda points and the deliberations followed as under:
  - a) Court Case in NCGRC New Delhi.
    - i) The General Secretary apprised the House that he alongwith Lt Col Kulwant Singh, Treasurer attended the court hearing on 15<sup>th</sup> May 2017 in National Commission in New Delhi. The advocates of AWHO raised objection with regard to have not filed a copy of our Society Bye-laws and the list of Society Members with the writ petition though the same were supplied/available with the AWHO. The worthy Judges, however, advised us to file all the documents, as pointed out by the respondents, in the Court to which our counsels instantly agreed and the case was thus adjourned to 31<sup>st</sup> July 2017 for arguments. The House unanimously resolved that General Secretary Sh. Subhash C Pathania should represent the President of the Society in the Court Case and with the help of Treasurer Lt Col Kulwant Singh he may, in consultation with the Advocates, complete all the relevant documentation for filing the same in the H'ble Commission timely.
    - ii) The General Secretary averred that earlier the Vakalatnama in r/o the captioned court case was signed by the then President Brig(Retd) Sarjit Singh, and in view of the election of Col (Retd) S K Chauhan as the existing President wef 16<sup>th</sup> June 2016, the relevant document(s)/case have to be signed/persued by the latter. The House (Managing Committee), therefore, unanimously resolved/ consented that President of the Society Col (Retd) S K Chauhan may do the needful in this regard in t/o Para 20 (xi) of Society Bye-laws and he, as President of the Society, can also authorize any other office bearer/member of the Managing Committee/Society to represent him in the Court of Law/Commission as and when necessary.

#### 4. <u>Conduct of Elections for the Collegium</u>

- a) The President Col SK Chauhan informed the House that a good number of society members have evinced keen interest in the process of election of the Collegium as 85 (eighty five) members as at Annx 'A' have applied for the same by the due date viz 20<sup>th</sup> May 2017 (1300 hrs) a healthy sign for democratic functioning of the society management. The scheduled date & time for withdrawal of nomination papers was 25<sup>th</sup> May 2017 (1300 hrs).
- b) He further informed the house that a few objections (through e-mails etc) and discrepancies as follows have been received/observed in r/o of these nominations pursuant to the relevant provisions of Society Bye-laws and Haryana Registration and Regulation of Societies Act 2012:-
- i) Applicants are on study leave and are expected to be posted out shortly;
- ii) Applicants are not posted in Station i.e.posted out and thus not residing-in;
- iii) Applicants are though in-living, but are out of station at the time of filing the nomination forms;
- iv) The spouse of one of the contestants threatened of dire consequences to a member resident of the same block a personal matter, yet to be probed into;
- v) Certain contestants not paid society dues till the scheduled last date of filling the nomination viz 20<sup>th</sup> May 2017 (1300 hrs) though have given the undertaking in the proforma that all society dues had been paid till that date.
- vi) Nomination papers received from non-members or late/withdrawals etc.

The house deliberated these issues threadbare and after going through the details/ credentials of the affected contestants, complaints, withdrawals, scrutiny and late receipt of the nomination papers, the unanimous decision/recommendations of the House have been detailed item-wise as at Annx 'B' attached.

- c) In view of the fore-goings the tentative list of candidates/contestants for election to the Collegium 2017-20 of GHS-79 as at Annx 'C' attached has been unanimously recommended by the House.
- 5. There being no other point for discussion, meeting ended with a vote of thanks to the Chair.
