Aspiring members can apply for only one post.


2. **Election Schedule.** Schedule for Elections shall be as under:-

3. **Appointment of Returning Officers and Independent Member.** The names of Returning Officers and the Independent Member are being intimated separately.
4. **Appointment of Observer.** The management will approach the District Registrar, Panchkula for appointment of an Observer.
5. **List of Members.** List of members is being separately posted on the Society Notice Board as well as on Society website, "sandeepans.com", for filing objections, (if any), till 26 May 2026. Any such requests can be made in writing to the Society Office or by email from the email id of the member as recorded in the society records, with copies of supporting documents.
6. **Instructions for Voting.** Detailed instructions regarding procedure for filing of nominations and voting will be issued by the Returning Officers, in due course.
7. **Ready Reference for all Election Related Issues.** A separate page has been opened on the society website "sandeepans.com" for posting of all election related messages and updates. Members are requested to visit the site regularly.
8. **Timely Clearance of Society Dues.** All members are reminded that in accordance with the Society Bye Laws and the HRRS Act, 2012, **those who have outstanding dues to the society for a period of more than 60 days on the first day of the month of election i.e. 01 Aug 2026, will not be eligible to vote, even if they deposit/clear their dues in the period intervening between 01 Aug 2026 and the date of election.** Hence all society dues be cleared at the earliest.
