**Duties of the Management**

4. The Management will be responsible for the following aspects pertaining to the elections.

- (a) Approach District Registrar, Panchkula for appointment of Election Observer under the provisions of Para 39 (11) of the HRRS Act,2012.
- (b) Issuance of list of members.
- (c) Resolve all issues related to membership.



- (d) Issue the list of members not entitled to vote due to nonpayment of society dues.
- (e) Provide secretarial support to Returning Officers.
- (f) Video recording of the elections on 02 Aug 2026.
- (g) On the day of the voting, to provide administrative support to the election staff.

#### **Duties of Returning Officers.**

5. Returning Officers will be responsible to oversee the entire electoral process after the issuance of notification for elections, till the announcement of results. Secretarial support will be provided by the General Secretary. The specific duties will be as under: -

- (a) Prepare the Nomination Forms.
- (b) Arrange for issuance of Nomination Forms.
- (c) Scrutinize filled Nomination forms for eligibility of the candidates.
- (d) Examine and rule upon any objections to candidature.
- (e) Publish the final list of candidates.
- (f) Preparation and accounting of Ballot papers.
- (g) Lock and seal the Ballot Box after inspection by candidates.
- (h) Conduct the elections by secret ballot on the designated date.
- (i) Separately seal the vote of any voter whose bona fides are in doubt.
- (j) Supervise the counting of votes and announcement of results.

#### **Procedure for Conduct of Election.**

6. Nomination forms will be available for collection by prospective candidates from the Society Office from 22 June 2026. Completed Nomination Forms will be submitted in sealed envelope to the Society Office by 5 PM on 12 Jul 2026 and the deposit will be recorded by the Office Superintendent.

7. Election will be conducted in the Community Centre.

8. Voting will commence at 8.30 AM and will continue till 1.30 PM. However, in case there are voters waiting to vote at 1.30 PM, the Returning Officers may permit voting to continue till such voters have been able to exercise their franchise.

9. Counting of votes will commence at the earliest thereafter.

#### **Procedure to be followed for voting.**

- 10 (a) Arriving voters will be checked against the list of entitled members by the Office Superintendent and issued with a serial token for voting. The Office Superintendent will verify the availability of a society membership card. In case the same is not held then he will arrange for a photocopy of the supporting identity proof to be made.



(b) The voter will thereafter proceed to the Returning Officers Stand. The Returning Officers will:-

(i) Verify the identity of the voter and reconfirm the eligibility of the voter to cast a vote based on the final list of members eligible to vote.

(ii) In case of voting by Joint Member, apart from verifying the identity of the voting joint member, they will also verify that an authorization from the first member has been recorded in the final list of voters.

(c) The voter will be issued a ballot form which will be filled at one of the available voter tables.

(d) The voter will thereafter deposit the completed vote in the sealed Ballot Box and leave the venue.

(e) In case the bona fides of any voter are in doubt, then the ballot will be sealed and counted only if required, after ascertaining correctness.

### **Verification of Voter**

11. Verification of the voter will be done through the Society Membership Card. Where the society membership card is not produced, any of the following proofs of identity will be accepted:-

- (a) Adhar card.
- (b) Driving License
- (c) Voter ID Card
- (d) Passport.

12. A self attested copy of the accepted document will be retained as a record.

### **Procedure for Counting of Ballot Papers.**

13. (a) Apart from the Returning Officers and Independent Observer, desirous candidates/ their representatives will also be permitted to be present during the counting.

(b) The seal on the ballot box will be verified in front of all present and then opened.

(c) Any ballot where more than the specified number of candidates have been voted for, will be rejected only for the category in which the over voting has taken place. i.e. more than one candidate ticked for the individual appointments or more than six candidates ticked for member category.

(d) Any ballots which have earlier been sealed due to doubts about the bona fides of the member, will be opened only if their number will make a difference to the outcome of any category.

**Duties of Independent Observer.**

12. The Independent Observer(s) shall remain present during the entire period of voting and counting of results and shall monitor that the election norms have been followed. In case of any observations, the Observer(s) shall endorse the same on the result sheet of the election.

**Voting by Joint Members**

13. In case the first member desires to authorize the joint member to exercise the vote, then an application to this effect will be submitted by the first member to the Society Office before 1 PM on 01 Aug 2026. The same shall be verified for correctness by the Returning Officers and endorsement made in the final list of members entitled to vote. Authorizations which may be produced at the time of voting will not be accepted since verification of the same would not be possible.

14. The decisions of the Returning Officers on all issues will be final.
